SECTION I. TITLE

The Village Board of the Village of Sherman hereby amends its Sewer Rent Law 2-1980, Sewer Rent Law 2-2018, and Sewer Rent Law 3-2020, as follows:

SECTION II. FINDINGS AND RATES

The fees for the Sewer Rent are hereby amended to:

- A. The fees for the Sewer Rent Charges shall be established by resolution of the Village Board of Trustees of this Village of Sherman.
- B. Such Schedule of Fees may thereafter be amended from time to time by like resolution.

SECTION III. TERMS AND CONDITIONS

All other terms and conditions of the Village's Sewer Rent Law shall remain in full force and effect, except as may be amended herein.

SECTION IV. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing with the Secretary of State of the State of New York, in accordance with the Municipal Home Rule Law Section 27.
