RES 2022-08-31.1: RESTORE NY APPLICATION TO NYS ESD

Motion to approve the application to NYS Empire State Development for \$2 million for the proposed \$2,222,222 project to rehab 130 W Main St for the use as a community center, and approve and authorize the mayor to sign all related documents and pay the \$500 application fee; final application due October 11, 2022, by 3:00 pm.

Motion to approve the one-time \$200 donation to the Sherman-Ripley-Clymer Wild Eagles Youth Football and Cheerleading Program.

The duty of the mayor is to appoint all non-elected officers and employees. Skilled positions under the Streets, Water, and Sewer departments are posted and interviews are performed by the department heads, at their recommendation the mayor makes the final determination for hire. Seasonal and general labor positions are not regularly posted. The Village is open to accepting applications at all times, available from the clerk-treasurer. The mayor heavily weighs the opinion of the department heads charged with the responsibility to supervise the laborer(s) and oversee operations. Since the Village staff has been reduced by students returning to college and a medical absence, there is a need to fill mowing, trash collection, and weekend utility services.
