#### Section I. Title

The Village Board of the Village of Sherman hereby amends its Water Rent Law 2-1980, and Water Rents Law 1-2018 as follows:

#### Section II. Findings and Rates

The fees for the Water Rents are hereby amended to

A. Increase the base water service charge to \$27.50/month per EDU (equivalent dwelling unit) beginning June 1st, 2022; B. Increase the base water service charge to \$30.00/month per EDU (equivalent dwelling unit) beginning June 1st, 2023; and

#### Section III. Terms and Conditions

All other terms and conditions of the Village's Water Rent Law shall remain in full force and effect, except as may be amended herein.

#### Section IV. Effective Date

This Local Law shall take effect Wednesday, June 1st, 2022, on all service charges accumulated beginning June of 2022. This Local Law shall take effect after the passage by the Village Board and filing with the Secretary of State in the manner provided by law.
