RES 2021-09-22.1: MATERIAL STANDARDIZATION RESOLUTION (HYDRANTS, etc.)

Motion to approve standardization of water system components for the Village of Sherman Drinking Water System:

VILLAGE OF SHERMAN RESOLUTION NO. 2021-09-22.1

AUTHORIZATION TO STANDARDIZE WATER SYSTEM COMPONENTS

WHEREAS, the Sherman owns and operates a water system containing a significant number of curb valves, corporation stops, gate valves, and fire hydrants;

WHEREAS, the majority curb valves, corporation stops, gate valves, and fire hydrants are all the same model and produced by the same manufacturer;

WHEREAS, utilizing the same model curb valves, corporation stops, gate valves, and fire hydrants is essential for system continuity, reducing required spare parts, and ease of operation and maintenance;

WHEREAS, standardizing on specific makes/models of curb valves, corporation stops, gate valves, and fire hydrants will provide significant benefit and is deemed to be in the public interest; and now therefore,

BE IT RESOLVED, that the Village Board of the Village of Sherman authorizes the standardizing on the following products: Curb valves: Mueller B-25209N; Corporation stops: Mueller B-25008N; Gate valves: Mueller A2362 or A2361; and Fire hydrants: Mueller Super Centurion 250.

Motion to approve the third change order with contractor J.D. Northrup for the Water Improvement Project:

Change Order No. 3

To add the replacement of an additional 1,250 LF section of water main and appurtenances along Cornish Street.

The increase from Change Orders 3 totals \$115,341, bringing the No. 1A – General Construction cost total to \$1,322,551.50.
