MINUTES OF THE SPECIAL BOARD MEETING

Wednesday, January 3rd, 2024, at 6:45am

Mayor Meeder called the special meeting to order at 6:48am and lead everyone in the Pledge of Allegiance. Board members Colleen Meeder, Ryan Sanders, and Gary Emory were in attendance.

RES 2024-01-03.1: WATER CAPITAL PROJECT DEBT REPAYMENT SCHEDULE

Motion to approve the thirty-year debt repayment schedule with NY State Environmental Facilities Corporation (NYSEFC) for the Drinking Water Improvement Capital Project (No. 18806); this is for the conversion of the short-term financing to long-term financing, at zero percent interest with the hardship awarded the Village of Sherman by NYSEFC, and

WHEREAS, the Village of Sherman has been provided two debt repayment options by NYSEFC that equal the same principal amount to be repaid to NYSEFC at zero percent interest over thirty years, and

WHEREAS, the <u>Next Level Debt</u> payment schedule is for payment of the same amount over each of the thirty-years, and

WHEREAS, the <u>50% Rule</u> applied to the payment schedule has the first year at a lower principal payment amount, gradually increasing each year by approximately \$400/yr, or on the average of a 1.5% increase each year.

THEREFORE, BE IT RESOLVED, that the Village of Sherman Board of Trustees hereby approves and authorizes the clerk-treasurer to select and execute the 50% Rule Debt Repayment Schedule for the thirty-year financing of the Water Capital Project with NY State Environmental Facilities Corporation.
